B. DISCUSSION AND POSSIBLE ACTION REGARDING ITEMS FOR INDIVIDUAL CONSIDERATION

1. Discussion of personnel issues with the following real estate managers:

- **a.** The RREEF Funds
- **b.** L&B Realty Advisors

Karen Knudson and John Robertson, of RREEF, discussed personnel changes within their organization and reviewed the performance of the Pension System's Real Estate Investment Trust (REIT) portfolio.

L & B representatives discussed the status of their firm and future plans relative to the recent acquisition of L & B's parent company, United Asset Management Corporation, by Old Mutual PLC. Messrs. Smith and Plumlee spoke about the overall direction of the firm, while Fitzenhagen, Mullis, Comey, Yagmur, and Tucker spoke about their respective areas.

2. Russell Real Estate Advisors' (RREA) reports and recommendations

- **a.** Discussion of the real estate investment consultant's recommendation regarding the following real estate managers:
 - (1) The RREEF Funds
 - (2) L&B Realty Advisors
- **b.** Real Estate Investment Trust (REIT) Manager Study
- **c.** Quarterly real estate investment performance report for the third quarter ended September 30, 2000

Ms. Broad, the System's real estate investment consultant, discussed the organizational changes at RREEF and L & B Realty Advisors.

After discussion, and based on the consultant's recommendation, Mr. Edge made a motion to place. The RREEF Funds on a "watch list" status. The motion included keeping L & B Realty Advisors on a "watch list" status, but allowing them to continue investment transactions for the Pension System while requiring a quarterly report to the Board. Mr. McCollum seconded the motion, which was unanimously approved by the Board.

The Board tabled the discussion of the REIT Manager Study, pending completion of the System's asset reallocation.

2. Russell Real Estate Advisors' (RREA) reports and recommendations (continued)

Ms. Broad reviewed with the Board the quarterly real estate performance report for the third quarter ended September 30, 2000. The highlights of the real estate portfolio activity are as follows:

- The total real estate investments at quarter end were \$353,679,261, comprised of \$266,524,323 in funded investments and \$87,154,938 in outstanding commitments.
- The total gross portfolio return for the quarter was 3.1%, comprised of 1.0% income and 2.2% appreciation, underperforming the benchmark average of 4.4% (2.0% income and 2.3% appreciation).
- The total gross return of the total portfolio for the last four quarters ended September 30, 2000 was 14.2% (6.2% income and 7.7% appreciation), underperforming the benchmark average of 14.9% (8.3% income and 6.2% appreciation).

Ms. Broad reviewed with the Board Russell's observations regarding each of the Pension System's real estate investments and reviewed each of the real estate managers for the period ended September 30, 2000.

After discussion, Mr. McCollum made a motion to receive and file the quarterly real estate performance report for the third quarter ended September 30, 2000. Mr. Edge seconded the motion, which was unanimously approved by the Board.

5. Approval of Election Schedule and call for 2001 Trustee Election

Steve Umlor Police Trustee (Place P-1)

The Trustee Election Procedures state in Section 3(a) that "The Board shall call an election and specify the voting period to elect Fire and Police Department Trustees and Pensioner Trustees at least sixty (60) calendar days before the term of any Police or Fire Department Trustee or Pensioner Trustee expires and at least sixty (60) calendar days before the first Pensioner Trustee election."

The Board reviewed the following:

- **Trustee Election Schedul**e approved by the Board on November 9, 2000
- **Trustee Election Procedures** as amended by the Board through November 9, 2000
- Proposed Application for Trustee packet

Telephone voting was the method used in the 1999 Trustee Election. Staff recommended using the telephone balloting again for the 2001 Trustee Election.

After discussion, Mr. Edge made a motion to call for the 2001 Trustee Election, approve the Application for Trustee packet, and approve telephone voting. Mr. Tomasovic seconded the motion, which was unanimously approved by the Board.

7. TEXPERS membership for the System Employees' Money Purchase Plan

Berger Funds has offered to sponsor a membership in the Texas Association of Public Employee Retirement Systems (TEXPERS) for the Pension System employees' Money Purchase Plan. This would increase the Pension System's voting strength at TEXPERS.

After discussion, Mr. Edge made a motion to approve the Berger Funds offer to sponsor a TEXPERS membership for the Pension System employees' Money Purchase Plan. Mr. Umlor seconded the motion, which was unanimously approved by the Board.

9. Internal Revenue Service tax qualification

The Administrator discussed an opinion letter that the System received from the Internal Revenue Service (IRS) regarding the System's tax qualification status. The IRS stated that minor amendments to the Combined Pension Plan are needed. Sections 3.01(q) and 8.01(i) of the Combined Pension Plan allow the Board to make changes to the Plan document that are necessary to retain its tax qualification status. The Board discussed an amendment proposed by Mr. Fields, the System attorney. The amendments are minor and technical in nature.

Mr. Tettamant stated that the 401(k) Board has had to approve similar technical amendments to the 401(k) plan. Their response to the IRS has already been sent to Gus Fields for further review.

The Board discussed a proposed revised DROP Policy, which allows the transfer of DROP account funds to a 401(k).

9. Internal Revenue Service tax qualification (continued)

After discussion, Mr. Edge made a motion to approve the amendments that are necessary for Internal Revenue Service qualification and to direct the staff to proceed with the qualification process. The motion also included receiving and filing the status report on the transfer of DROP funds to 401(k). Mr. McCollum seconded the motion, which was unanimously approved by the Board.
