To Whom It May Concern:

On or about September 22, 2003, you forwarded the attached open records request to Mr. Teodoro J. Benavides, Dallas City Manager, requesting information regarding "the Dallas Police and Fire Pension System, its employees, and its Board of Trustees (collectively, the "Pension System"). The City of Dallas forwarded the request to the Pension System. The Pension System received your request on September 24, 2003.

The documentation you requested in item #1 for fiscal years 1999 through 2003, to the extent that it exists in System records, is provided in the information attached.

The System has no documentation responsive to items #2 and #3. All other trustees who left trustee position during the period covered by your request left because either (1) their term expired and they were not reappointed or (2) they left employment with the City and no longer met eligibility for the position.

If your organization makes any future requests for open records information, we will be able to respond in a more timely manner if requests are made directly to the Pension System. Sending requests through the City Manager delays our response by several days. We also note that the requests received to date from your organization have not been signed. We ask that requests be signed by an authorized representative to assure that we are responding to something that was intended by the entity.
