RE: Texas Public Information Act (PIA) Request

Pursuant to the Texas Public information Act (Texas Open Records Act), Chapter 552, Texas Government Code, I am requesting the following information regarding the Dallas Police & Fire Pension System, its employees, and its Board of Trustees:

Please identify the location (i.e., street address, city, state, zip code) or locations (if more than one) of the "office property" as referenced in the Minutes of the Pension System's Board of Trustee Regular Board Meeting of Thursday, December 9, 1999, page 4, paragraph underscored (copy enclosed).
2. Please provide the check number, check date, check amount, and payee for any and all payments made by the Pension System for the purchase of the "office property" referenced in item #1 above.
3. Please provide the complete name and address of "L&B" as referenced in the Minutes of the Pension System's Board of Trustee Regular Board Meeting of Thursday, December 9, 1999, page 4, paragraph underscored (copy enclosed).
4. Please provide the check number, check date, check amount, for any and all payments made by the Pension System to L&B for the "due diligence and legal work and execution of the contract" as referenced in the Minutes of the Pension System's Board of Trustee Regular Board Meeting of Thursday, December 9, 1999, page 4, paragraph underscored (copy enclosed).
5. Please provide the check number, check date, check amount, for any and all payments made by the Pension System to L&B during the period from October 1, 1999, through December 31, 2002.

Please note that the payment information requested above is typically stored electronically in the vendor history and cash disbursements journal for accounts payable, and should be readily available to the Pension System unless purged. If the aforementioned transaction history is no longer available, please provide the date(s) on which the information was purged, and the reason(s) for its destruction.

In addition, if the aforementioned information is believed stored at an off-site location, please identify the storage box number(s), date(s) of storage, and complete contents of each storage box believed to contain the information responsive to this Open Records Request.

Finally, please note that I am requesting that copies of the above be produced through your office, and agree to pay the charges related to this Open Records Request. Please advise should you have questions, comments or require additional information. Thank you.
