On January 18, 2000, the Dallas Police and Fire Pension System created a corporation called PFP Akard Place, Inc. ([Exhibit "A"](#)). On April 14, 2000, the Dallas Police and Fire Pension System acquired seven commercial properties in and around the downtown Dallas Victory Project area, to include the four-story office building now used by the Dallas Police and Fire Pension System for its offices and Board room ([Exhibit "B"](#)).

On May 16, 2000, the Dallas Police and Fire Pension System issued a \$1,546.58 payment to City Councilman Donald W. Hill ([Exhibit "C"](#)). Pursuant to the Texas Public Information Act, Chapter 552, Texas Government Code, please identify the purpose of the \$1,546.58 payment and, if travel related, please identify the destination and time spent on location. Additionally, please provide a copy of any and all written agreements by and/or between City Councilman Donald W. Hill and the Dallas Police and Fire Pension System executed on or after January 01, 2000.

Please note that we are requesting that your office compile information responsive to this Open Records Request, and that a written itemized statement of estimated charges be provided in advance of work being started should the estimated charge exceed \$10.
