### Governor Abbott Appoints New Board Member



**O**n December 21, 2021, Governor Greg Abbott appointed new Board member Himesh M. Gandhi, Esq. to serve on the Texas State Board of Public Accountancy (TSBPA) for a term set to expire on January 31, 2025.

Mr. Gandhi is an equity partner and attorney at Roberts Markel Weinberg Butler Hailey PC. Mr. Gandhi represents individuals and entities in complex business transactions and litigation matters. His primary areas of

focus are in real estate, construction, mergers and acquisitions, commercial disputes, finance, and general corporate matters.

Mr. Gandhi has served as a Sugar Land City Council member and is Board certified in Commercial Real Estate by the Texas Board of Legal Specialization. He has also served as vice chairman of the Arc of Fort Bend, and as a board member for the Fort Bend Chamber of Commerce and Child Advocates of Fort Bend. He is a member of the State Bar of Texas and the Fort Bend Bar Association. ## Fingerprinting Updates

**M**ore than 43,600 Texas CPAs have been fingerprinted but there are a remaining 10,600 who still need to be fingerprinted by the September 1, 2022 deadline. Approximately 20,000 CPAs were fingerprinted as Exam candidates. Don't procrastinate and delay any longer than is necessary to complete this important requirement! As a reminder, all non-CPA owners in Texas firms are also required to complete the fingerprint-based background check. Licensees who hold the retired or disabled status with the Board do not need to get fingerprinted, unless they return to active status.

Check your fingerprinting status or learn how to complete this requirement by following the instructions on your account page after logging in to [Online Services](#). Fingerprinting services are provided by IdentoGO and there are plenty of appointments available across the state. The Board will usually receive your fingerprinting results within 48 hours after you have been fingerprinted.

Please keep in mind the decision to make fingerprinting mandatory for all Texas CPAs was not made by the Texas State Board of Public Accountancy. The Sunset Commission made the recommendation to the Texas Legislature in 2019 that all CPAs should be fingerprinted. The Texas Legislature has previously mandated fingerprinting requirements for other licensed professionals such as doctors, nurses, architects, engineers, pharmacists, lawyers, and realtors.

Although this program has been very successful, we know that there continues to be false or misleading advertising. There are approximately 75,000 licensed CPAs in Texas who can help protect the public from individuals and firms misrepresenting their qualifications.

On February 24, 2021, the Behavioral Enforcement Committee (BEC) found that Mark J. Trappio received deferred adjudication for assault in July 1997, was convicted of possession of marijuana in April 2003, was convicted of driving while intoxicated (DWI) in February 2005, was convicted of DWI 2nd in July 2010, received deferred adjudication for assault causing bodily injury to a family member in September 2011, and was convicted of DWI 3rd in September of 2016, a felony. None of the criminal actions were reported to the Board as required by Board rule or during his license renewal application. Respondent then provided altered documents to the Board.

The BEC offered Respondent an ACO ordering his certificate be revoked, and requiring Respondent to pay the Board's direct administrative costs incurred in the investigation and prosecution of this matter. Respondent did not accept this offer.

Pleadings were filed with the State Office of Administrative Hearings and after notice of hearing, Respondent failed to appear. The State Office of Administrative Hearings Administrative Law Judge (ALJ) granted staff's Motion for Default, remanding the matter to the Board and staff recommending that the Board find that: 1) Respondent violated Board *Rules* 501.90(4), 501.90(5), 501.90(13), and 501.91 as well as *Sections* 901.502(6) and 901.502(11) of the *Public Accountancy Act*; 2) Respondent's individual certificate be revoked; and, 3) Respondent be assessed \$425.60 in administrative costs.

## Continuing Professional Education Actions
