### C. DISCUSSION AND POSSIBLE ACTION REGARDING ITEMS FOR INDIVIDUAL CONSIDERATION

#### 1. First reading of the 2009 Administrative and Professional Services Budgets

Mr. Tettamant stated that the proposed Administrative and Professional Services Budgets for Fiscal Year 2009 were presented to the Board for review and comments at the September 11, 2008 meeting.

The Board authorized the first reading of the budgets to be presented at the October 9, 2008, Board meeting. The proposed budgets were distributed to Members with the September newsletter on or about September 29, 2008.

No changes have been made to the budgets as presented at the September 11 meeting.

After discussion, Mr. Shaw made a motion to approve the first reading of the Fiscal Year 2009 Administrative and Professional Services Budgets and authorize the second reading to be presented at the November 13, 2008, Board meeting. Mr. Tomasovic seconded the motion, which was unanimously approved by the Board.

### 2. Amendment to contracts

Mr. Tettamant explained that the General Partner of Lone Star Fund VI (U.S.), L.P. and Lone Star Real Estate Fund (U.S.), L.P. is requesting certain amendments to the Limited Partnership contracts. The proposed amendments are either investor friendly or clarifying in nature.

Two summary memos from Lone Star regarding the amendments were provided. The proposed amendments in draft form were also attached.

The System has a \$25 million capital commitment to Lone Star VI and a \$25 million capital commitment to Lone Star Real Estate Fund.

#### 2. Amendment to contracts (continued)

After discussion, Mr. Wachsman made a motion to approve the amendment to Lone Star Fund VI (U.S.), L.P., subject to the final approval of the Administrator and legal counsel, and to approve the amendment to Lone Star Real Estate Fund (U.S.), L.P., subject to the final approval of the Administrator and legal counsel. Mr. Shaw seconded the motion, which was unanimously approved by the Board.

#### 3. Possible new investment in California

Mr. Tettamant explained that a possible new real estate investment in California is being offered by one of the System's developer operators. The System representatives to the Napa project's executive board strongly support this additional investment. This is an integral part of an existing investment in California. It is believed that the three parcels of land could be sold at a profit as this is a distressed sale that must concluded by October 31, 2008. The cash outlay for this investment is minimal.

The Board went into a closed executive session – real estate at 8:37 a.m.

The meeting was reopened at 8:49 a.m.

After discussion, Mr. Wachsman made a motion to pursue the additional real estate opportunity, subject to successful due diligence, contract negotiations, and the final approval of the Administrator and legal counsel, to authorize the Chairman to execute the contract, and to authorize the Administrator to perform all necessary acts and exercise all appropriate discretion to consummate the investment and ongoing operation. Mr. Shaw seconded the motion, which was unanimously approved by the Board.

4. Adjustments for retirees and survivors of the Combined Pension Plan, Sections 6.01 (b) and (e), 6.04 (b) and (c), 6.05 (b), and 6.07 – Group A; and Sections 6.02, 6.04(e), 6.05 (c), and 6.08 – Group B, to be effective October 1, 2008

Mr. Tettamant explained that the Combined Pension Plan, Section 6.12, provides for an adjustment to base benefits being paid as of October 1 of each year to Pensioners retired under:

- 4. Adjustments for retirees and survivors of the Combined Pension Plan, Sections 6.01 (b) and (e), 6.04 (b) and (c), 6.05 (b), and 6.07 – Group A; and Sections 6.02, 6.04(e), 6.05 (c), and 6.08 – Group B, to be effective October 1, 2008 (continued)
  - Sections 6.01(e), 6.04(c), and 6.05(b) (other than the last sentence of Subsection 6.05(b)) Group A (formerly Plan A), and
  - Section 6.02 and 6.04(e) and 6.05(c) Group B (formerly Plan B)

The adjustment is also payable to the survivors of each group above.

This annual adjustment is payable in an amount equal to four percent (4.00%), not compounded, of the original base benefit; however, should the Section 6.01(b) (Old Plan) benefit be greater than the benefit under Group B for any Pensioner, the higher amount will be paid, provided the member or survivor was eligible to receive a Group A Section 6.01(b) benefit.

Arnett-eligible Old Plan Pensioners receiving an Old Plan benefit, except as provided above, and minimum benefit recipients will not receive the annual adjustment increase.

Approximately 3,500 benefit recipients and DROP members are eligible for this benefit. About 3,000 of these will receive an increase. (For example, members receiving a minimum benefit do not receive the annual adjustment.)

The base benefit for Section 6.01(b) and 6.04(b) Group A (formerly Old Plan) pensioners and survivors is computed as 50% of the maximum pay of a 15-year police officer or firefighter. The City Council authorized the Uniformed Fire and Police Salary Schedule be revised to reflect a 5% pay step to be added to all ranks, effective January 1, 2009. Group A (formerly Old Plan) pensioners and survivors will receive a benefit increase based on the new rate at that time. Approximately 990 Old Plan members will be eligible for the increase.

After discussion, Mr. Umlor made a motion to approve the annual adjustments. Mr. Wachsman seconded the motion, which was unanimously approved by the Board.
