# **Amendment Election Results**

Thank you to the 1,220 police officers and firefighters who voted in the Plan Amendment Election. All amendments passed!

The Board of Trustees met on December 18 and certified the results of the Plan Amendment Election. Each amendment was approved by

at least 65 percent of the votes cast.

■ Amendment 1—Allow payroll deductions for Pension Service purchase on a pre-tax basis.

Passed with 98.44% in favor Fire: 451 in favor, 10 against Police: 750 in favor, 8 against

■ **Amendment 2**—Allow rollovers for Pension Service purchases with pre-tax dollars.

Passed with 97.95% in favor

Fire: 446 in favor, 15 against Police: 749 in favor, 9 against

■ **Amendment 3**—Permit partial Pension Service purchases.

Passed with 97.87% in favor Fire: 448 in favor, 14 against Police: 746 in favor, 12 against

■ **Amendment 4**—Provide a non-service disability pension for a person disabled while on military leave of absence.

Passed with 96.48% in favor Fire: 442 in favor, 20 against Police: 735 in favor, 21 against

Amendment 5—Provide a 100 percent joint and survivor annuity option.

Passed with 98.11% in favor Fire: 449 in favor, 12 against Police: 748 in favor, 10 against ■ **Amendment 6**—Increase pensioner and qualified survivor minimum benefits.

Passed with 98.85% in favor Fire: 453 in favor, 8 against Police: 753 in favor, 5 against

■ **Amendment** 7—Increase DROP interest, and base future changes on System's 10-year investment return.

Passed with 98.20% in favor Fire: 453 in favor, 8 against Police: 745 in favor, 13 against

■ **Amendment 8**—Require special elections to fill vacant trustee positions.




■ **Amendment 9**—Make Combined Pension Plan technical and grammatical language revisions.


