Due Diligence and Investing

In the last issue of the *Pension Update*, Fire Trustee George Tomasovic explained that the Board of Trustees had voted to make several changes in the management of the System's investment port-

folio. Some of the changes require us to do business with companies we have not worked with previously.

The Board considered several companies for changes in three areas: real estate investment consulting, international investment management, and energy investment management. Once a "short list" of three companies was determined in each of the categories, it was time to begin our due diligence research.

The Board and staff have a fiduciary responsibility before investing your pension dollars to ensure that the firms with which we do business are capable of performing the services we require from them. Part of that responsibility requires us to physically visit the companies at their facilities. This research is called due diligence.

From early September to late December 2001, Board Trustees and staff members of the Pension System have been busy conducting due diligence

meetings across the country—literally from Boston to Los Angeles and several points in between.

At each site, we looked at the candidate company's office, its personnel, and its general ability to carry on business. We met with management to learn details about investment and reporting policies. We also looked at client-manager accessibility, data back-up, security, and privacy concerns.

Once those issues were covered, we took a comprehensive tour of the company. We watched its operations in progress, observed the systems, and asked its staff members questions while they performed their job duties.

All that done, we took coach seats back to the Pension System office to decide

which of the companies would provide the best returns and service.

The Board then chose The Townsend Group as

our real estate consultant, added Clay Finley and Fidelity Investments as international managers, and selected The Mitchell Group to manage investments in the energy sector.

Federal Tax Changes Help You Save for Retirement

Last year's federal tax bill made significant changes to income tax rules that included several provisions that may affect your retirement planning. The City has adopted provisions to implement the most notable feature of the new rules. Now, if you are buying Pension Service under provisions in the Combined Pension Plan Document, you can transfer funds from your City 457 deferred compensation account to the Pension System as payment toward the purchase. The tax bill also allows DROP participants to spread payments from their DROP accounts over a longer period of time.

Several additional changes may affect your participation in the City's 401(k) and 457 plans. Consult your 401(k) and 457 plan representatives for details on the following:

- Increases the amount you can contribute to the City 401(k) and 457 plans
- Removes restrictions when contributing to both 457 and 401(k) plans
- Increases make-up deferrals by members of a 401(k) plan who are over age 50
- Applies tax rules regarding divorce situations to 457 plans


