## Benefits for Special Needs Children

I recently spoke with a member who was not aware of the benefits available to his special needs child. I too, have a special needs child, and want to make sure that he is taken care of in the future.

Your special needs child (minor or adult) may qualify for survivor benefits from the Dallas Police & Fire Pension System.

If you have a physically or mentally handicapped unmarried child who cannot support himself or herself or hold gainful employment, your child may receive your survivor benefits beyond the age of 19. However, for the child to be eligible to receive survivor benefits, the handicap must have occurred before the child reached age 23.

If the handicap was self-inflicted, resulted from substance abuse, or occurred during the commission of a felony, the handicapped child will not be eligible for survivor benefits. In addition, if the handicap occurred during your child's employment, the survivor benefit will be offset by any benefits received by the child from the child's employer, former employer, Workers Compensation, or benefits that are provided or paid for by the employer instead of Workers Compensation.

#### **Trustee Election Results**

At the regular Board Meeting on April 14, the Board approved the results in the Pension System's Trustee election. Steve Umlor was unopposed for Police Trustee Place 1, and thus was elected. Police members did not need to vote.

A total of 562 Active Fire-Rescue members voted. Gerald Brown was elected with 464 votes (83%) while Willie Reynolds received 98 votes (17%).

#### **Benefits Counseling Services**

If you are considering retiring or joining DROP (Deferred Retirement Option Plan), you should meet with a Benefits Counselor at the Pension System.

Please schedule your appointment with a Benefits Counselor a minimum of 60 days before your planned retirement or DROP date. Allow more time, if possible. Counseling sessions last about one hour.

After you call for your appointment, we prepare a personalized pension information packet for you. If you wish, we will mail this information to you before you come in, giving you time to review the material, consider the various options, develop questions, and make important decisions that will affect you for the rest of your life. After receiving your pension benefit information, you also may want to consult your tax advisor or accountant before finalizing your retirement plans.

If you do not contact the Pension System before you leave Active Service, any payments that could be made from the Pension System may be delayed. For more infomation, call the Pension System office at 214.638.3863 or 1.800.638.3861.
