

# Pre-sales Going Briskly at Pension System's Dallas Condominium Developments

Two Dallas condominium developments owned by the Dallas Police and Fire Pension Fund are off to a great start. "The Beat at Southside Station," to be built in the 900 block of Belleview (across from Dallas Police Headquarters), had their ground-breaking on May 26th. The ten story, 72 unit Phase I of the development will offer homes ranging in price from \$170,000 to \$295,000. As of this printing, over 25% of the

The second development, located at 3030 Bryan Street (named the same as the address), will sport 38 luxury residential units, priced from \$250,000 to \$500,000. Construction is to be completed this fall. Seven reservations have already been taken on this development. The web site for the project is www.3030bryan.com.

We will look at retirement investment strategy, estate planning, and pension benefits for active members and survivors. The program will also include an explanation of Minimum Required Distribution rules, and a presentation on health insurance and long-term care.

Both PREP and Financial Planning training can be used for TCLEOS (Texas Commission on Law Enforcement Officer Standards) credit for Police Officers

Reserve space in one of the Pension System's educational sessions. Seating is limited. These sessions are very popular and fill quickly, so do not delay. To attend, you must have five or more years Pension Service. The Pension System provides all materials and lunch, and we encourage you to bring your Spouse.

To attend, you must send a \$20 refundable registration deposit. If you attend the full day, your check will be returned. Because of the demand for participation, if you reserve a space and do not attend, you will have to wait 12 months before you can sign up again.

Many members decide to retire or enter DROP during the fall. If you are planning on retiring or entering DROP in September or October, now would be a great time to call and make an appointment with a Benefits Counselor for the end of July or August. It is best to meet with one of our counselors at least 2 to 3 months before you plan to retire.

You will need to bring the following documents to your appointment:

- Your birth certificate
- Marriage license/certificate
- Spouse's birth certificate
- Birth certificates of your children age 19 or younger

A Benefits Counselor will provide a Pension Benefit Application Form and explain:

- Your retirement options
- Estimates of your benefits
- Survivor benefits
- Post-retirement increases

We appreciate all that you do to keep the city of Dallas safe and secure.
