From the Administrator By Richard Tettamant, Pension System Administrator

Making the decision to retire can be exciting, but you may have some difficult choices to make. Your decisions will affect the rest of your life. Once

you decide to retire, the following steps should *Richard Tettamant* be followed in order to ensure a smooth transition into retirement:

1. Contact a Benefits Counselor at the Pension Office to schedule an appointment to retire:

2. Bring the following to the retirement appointment:

- Your spouse, if possible
- Your and your spouse's birth certificates
- Your and your spouse's original social security cards
- The names, social security numbers, and birth certificates of your children.
- A voided check from the account into which you want your monthly pension payment to be directly deposited. (Your name must be pre-printed on the check.)

3. The Benefits Counselors will explain your options and answer any questions. Before making your final decisions, discuss the retirement and DROP option available to you with your spouse, if applicable, and financial advisor.
