She is survived by her son, daughter-in-law, five sisters, a brother, and many nieces and nephews.




### "Dallas 9/11 Memorial March" a Success


On Saturday September 8, area Fire Departments joined with Fire Department elements from around the country for the Dallas 9/11 Memorial March.
