

Trustee Election is Underway -- Ends April 6

Voting in the 2009 Trustee Election began on Friday, March 27, and will end at noon on Monday, April 6.

The Board will certify the results of the election at the Board meeting on April 9, and will determine if there will need to be a run-

off election in any of the races.

Three active places are up for election. Lt. Gerald Brown is unopposed for Fire Trustee Place 1, so there will not be a race for that Trustee position. Lt. Brown will be deemed

elected in accordance with the Pension System's election procedures.

There are two candidates for Police Trustee Place 1: the incumbent, Sgt. Steve Umlor, and Sr. Cpl. Eric Jez.

DPFP Green Focuses on Environmental Responsibility

The Dallas Police and Fire Pension System believes in our responsibility to our members, their families, and future Police Officers and Firefighters. will positively affect our surroundings. We can accomplish this in a variety of ways.

Our new headquarters was using refurbished Green Building Standards, giving us a building which operates in such a way that it is more energy efficient and has less of an impact on the environment. A cistern is now being constructed for the collection of rainwater and re-use for irrigation. The building features large windows to let in natural light, and the lighting in the building utilizes compact fluorescent lights (cfl's) which use a fraction of the energy of conventional light bulbs.

Our Trustees have researched and invested in environmentally conscious investments. For instance, we have invested with Sustainable Asset Management (S.A.M.), a firm that invests in companies which deal in

things such as water, energy, resource efficiency, climate change and healthy living.

Another one of our investment managers, Ecotrends Investing, invests in companies which are committed to providing solutions to environmental concerns, including the EcoEnergy, Pollution Control, and Clean Water Sectors.

We invest in timber through RMK Timberland group, whose goal is to achieve competitive timberland investment returns while exercising environmental stewardship. They believe that active and environmentally responsible forest management is good business.

The City of Dallas is also very involved in environmental concerns. and we have provided a link to their Website, Green Dallas (www.greendallas. net). The site provides tips on "going green," along with information on air quality, climate change, green buildings, water, recycling, and more.
