Rep. Truitt is in her sixth term representing District 98 in the Texas House of Representatives. She is the current Chairman of the House Committee on Pensions, Investments and Financial Services, and is a member of the House Committee on Public Health.

Earlier this year, Rep. Truitt was instrumental in the demise of a bill that could have been detrimental to the local control of public pension Systems.

Fire Station #11 to Celebrate 100 Years of Service to Community

Fire Station #11 at Cedar Springs Road and Reagan Street will celebrate 100 years of continuous service with a celebration on Wednesday, November 18th, from 10:30 until 12:30.

Attendees are invited to bring photos of their time serving at Station #11. There will be food and beverages served.

Whether active or retired, anyone who has ever been assigned to Station #11 is invited. Please R.S.V.P. by November 1 (see form below).

When the station opened in 1909, it was known as No. 4 Hook and Ladder, referring to companies who carried ladders and ceiling hooks (pike poles). The station housed a Silsby steam engine (with iron wheels and carrying copper-riveted leather hose), a ladder company, some horses and a fire dog.

The station, which has been designated as a historical landmark, was designed by architects Hubbell and Green. They designed other notable Dallas buildings including First Church of Christ Scientist and the Scottish Rite Temple.

Station #11 was built as a sister station to Station #5 or "Old Tige," built at the turn of the century across from Fair Park and now housing the Dallas Firefighters Museum. These two stations are the last of their kind in Dallas.

The Department completely remodeled the station in 1985, adding an additional 1,000 square feet, bringing the total area to 10,561 square feet.

Several features built in Station #11 not in today's stations include a hose well drying rack that hoists the hose up for drying after use, and apparatus room doors that open from the side instead of bottom-to-top.

On the first Saturday of October each year, DPD retirees meet for a picnic at Hogg Park in Quitman. This year, it will be held Saturday, October 3,


The organizers invite active officers to attend as well.



Check the Accuracy of Your Pension Contributions When on Workers' Comp

If you are injured on the job and are being paid Workers' Compensation, you may be eligible to receive continuation pay from the City to make up the difference between your regular pay and Workers' Comp.

The City is required to withhold pension contributions from the continuation pay, equal to what it would withhold if you were receiving your full pay.

We have learned that in some

cases the City has withheld contributions only on the continuation pay amount. If this occurs, your pay is under-reported to the Pension System.

If you are, or have been, on Workers' Comp, check your City pay stub to make sure that the proper contributions were made to your Pension System.
