Trustee Election Information for Active Members of the Dallas Police & Fire Pension System

Board Schedules Trustee Election; Calls for Candidates

At its Board meeting on January 8, 2015, the DPFP Board of Trustees called for the regular Trustee Election for 2015 to be held March 27 - April 6.

The terms of four Active Trustee positions expire June 1, 2015 (two Police and two Fire Trustee positions). No Pensioner Trustee positions are expiring at this time. All Active Members are eligible to vote in the election.

The positions up for election are:

- •Police Trustee Place 2 (currently held by Joe Schutz)
- •Police Trustee Place 3 (currently held by Dan Wojcik)
- •Fire Trustee Place 2 (currently held by Rick Salinas)
- •Fire Trustee Place 3 (currently held by George Tomasovic)

Trustees are elected for a period of four years and may run for re-election.

If you are an Active Dallas Police Officer or Firefighter and would like to apply to be a candidate for one of these positions, you may pick up an application packet at the DPFP office beginning 8 a.m. Tuesday, February 17.

You will need to bring your Driver's licence and department-issued identification card. The Pension System office is on the first floor at 4100 Harry Hines Boulevard. Regular business hours of DPFP are from 8 a.m to 5 p.m., Monday through Friday. The packet must be completed and returned to DPFP no later than 4 p.m. Monday, March 2.

Candidates will be required to attend a Trustee Candidate class either March 9 or 10. At the March 12 Board meeting, the Board will certify the candidates in the election.

On March 26, election materials will be sent to each Active Member's home address on file with the payroll department. Voting will begin at 8 a.m. on Friday, March 27 and will end at 12 noon on Monday, April 6. February 17, 2015 - Trustee Candidate filing period begins at 8 a.m.

March 2, 2015 - Trustee Candidate filing period ends at 4 p.m.

March 9 & 10, 2015 - Trustee Candidate classes

March 12, 2015 - Regular Board Meeting. Board certifies Trustee applications

March 26, 2015 - Election ballots mailed

March 27, 2015 - Voting begins at 8 a.m.

April 6, 2015 - Voting ends at 12 p.m. (noon)

April 9, 2015 - Regular Board Meeting- Board certifies vote, decides if a run-off is needed, then reviews materials for run-off, if needed.

(If a run-off election is required, it will be conducted May 1-11. For updates, check **www.dpfp.org**)

June 1, 2015 - New terms begin.
