# **Board Meeting Recap: In first two meetings of 2016, Board looks at Investments and Professional Service Providers**

#### Board Meeting Recap – January 14, 2015

The Board was greeted with a full agenda as they arrived for the first meeting of 2016, held on January 14.

The first major item of discussion was from AEW, the Investment Manager which oversees our interest in Red Consolidated Holdings. AEW presented their recommendations for an investment in "The Union," a planned mixed-use real estate development on the site of DPFP's former offices at Akard and Cedar Springs in Uptown. The project will include first class office, residential, and restaurant spaces, along with a full-line grocery store and an open-air, landscaped pedestrian plaza.

the monthly investment reports.

In each Board meeting, there is a time for reports and concerns of active members and pensioners of DPFP. One pensioner spoke briefly, and urged the Board to continue to strive for transparency in communication with the membership.

The Board went into closed executive session to discuss legal issues. Upon returning to open session, the Board unanimously passed a motion to authorize the Executive Director to negotiate and execute an engagement agreement with the law firm Diamond McCarthy, LLP to pursue any relevant claims.

In two separate actions, the Board voted to cut ties with actuarial firm Buck Consultants and law firm Strasburger and Price. A committee was appointed to search for a law firm to provide outside counsel.

# Board Meeting Recap – February 11, 2015

The Board of Trustees met for their monthly meeting on Thursday, February 11.

Real Estate investments were the focus for the first part of the morning. One of DPFP's Real Estate Managers— L & B Realty Advisors, LLP— presented a review of the portion of DPFP's Real Estate portfolio which is under their management.

Next, the Board had a conference call with DPFP's Real Asset Investment Consultant, Townsend Group, regarding two real estate investments made in June 2015. The impetus for those investments was an earlier decision by the Board.

In January of 2015, the Board approved the Strategic Real Estate Allocation Plan, which recommends that over time, DPFP should transition the real estate portfolio to include a minimum allocation to core real estate. To begin implementation of the plan, at the June 18, 2015 meeting, the Board approved revocable commitments of \$50 million each to JP Morgan Strategic Property Fund (SPF) and Prudential PRISA funds, which are open-ended core real estate funds.

Based on the revocable nature of the commitments, the decision to enter the investment queues was made to give DPFP an option to confirm the investment or withdraw from the queue prior to any capital being called. DPFP has learned that the capital could be called by June this year. Given that the current allocation to real estate is 23% versus a target allocation of 15%, which may be reduced further based on the upcoming asset allocation recommendation, staff recommended that DPFP rescind the commitments to both funds, with the option to sell the PRISA commitment per Townsend's recommendation. The Board voted to accept the recommendation.

As DPFP prepares for an asset allocation recommendation, staff invited JPMorgan to provide an educational session reviewing the company's Long Term Capital Market Return Assumptions for 2016. They provided an overview of the return assumptions for various asset classes and explained

There were concerns about changes that might come to the plan in an amendment election. There were specific concerns about the Cost of Living Adjustment (COLA), and that retirees could not vote on any changes.

Due to open meetings laws, the Board may only discuss items which are on the agenda, so most of the direct questions during this time could not be discussed. The Executive Director assured the members and retirees that there will be meetings to discuss any

possible changes before any amendment election.

Next, the Board was informed that DPFP's comprehensive annual financial report for the year ended December 31, 2014 was awarded the Certificate of Achievement for Excellence in Financial Reporting by the Government Finance Officers Association of the United States and Canada (GFOA). The Board went into closed session to discuss legal issues for the rest of the morning, and then again after the lunch break.

In the afternoon, the Board received updates and briefings on <u>Business Continuity</u>, <u>Internal Controls</u>, and reviewed service providers.

The regular monthly meeting of the Board of Trustees is scheduled for 8:30 a.m. on the second Thursday of each month. The meetings are open to the public, but may go into closed session as permitted by Texas Government Code.
