Accountants Confidential Assistance Network

he Accountants Confidential Assistance Network (ACAN) provides free, confidential support to Texas certified public accountants, candidates, and accounting students who are struggling with substance abuse and/or mental health issues. Due to the high-stress nature of accounting work, these issues are not uncommon in the profession. Fortunately, ACAN provides services for alcohol and drug dependency, and wellness resources to help treat stress, depression, anxiety, and more. When someone calls ACAN for help they are matched with a trained mentor who can provide support and referrals to treatment programs. The network also hosts virtual peer assistance meetings that convene regularly via Zoom. Even if someone is not sure if they have a problem, or needs help managing stress and maintaining a healthier lifestyle, the network is available to them.

For over 30 years, ACAN has provided support to hundreds of CPAs and CPA candidates. The CPA volunteers in ACAN understand the unique pressures of the accounting profession. Many are successful CPAs that once faced problems and now want to share solutions by being friends and mentors to others. There is no stigma and there are no judgments in ACAN. Network volunteers have first-hand experience with some of the same issues others may be dealing with and understand what people are going through. Volunteers receive annual training in mental health and addiction issues, intervention methods, and anger management. They are available to motivate affected persons to seek help and to support them in their recovery.

The network is also completely confidential and available at no cost. The identity and communications of anyone contacting or participating in the network are confidential and protected by law under *Chapter 467* of the *Texas Health and Safety Code*. ACAN is administered by the Texas Society of Certified Public Accountants (although you don't have to be a Society member to access ACAN services) and funded in part by a large grant from the TSBPA. Board *Rule §502.2* enacted a TSBPA peer assistance program to oversee the activities of ACAN to provide confidential assistance to CPAs with alcohol or drug dependency and/or mental health issues and to protect the public.

Individual Licensing Fee Increase

s a result of the Board's projected revenue, expenditures, and fund balances, modest fee increases are necessary to maintain the same level of operations for Texas licensees. Effective September 1, 2024, the annual individual license fee will increase from \$97 to \$112 (includes \$10 scholarship fee). All other fees will remain the same. The Board is self-sustaining. All direct and indirect costs must be paid from what it collects in license renewal fees, firm registrations, exam fees, sponsor registrations, and other collections. The following table can be used as a general guide, but your individual fees may vary depending on your specific circumstances, the timing of your previous payments, and your current status with the Board. Please refer to Online Services for Individuals to check your specific status.

AGREED CONSENT ORDERS BEHAVIORAL ENFORCEMENT COMMITTEE

Respondent entered into an agreed consent order (ACO) with the Board whereby Respondent's certificate was suspended for two years. Following the suspension, Respondent's certificate will be revoked for a period of eight years; however, this revocation will be stayed and Respondent will be placed on probation to run concurrently with her criminal probation. In addition, Respondent will be required to participate in the Accountants Confidential Assistance Network and Alcoholics Anonymous. Respondent has a history of alcohol related convictions including a felony driving while intoxicated (DWI) 3rd in 2023 as well as a deferred adjudica-

tion for felony evading arrest in 2023.

Respondent Hald shall complete eight hours of technical continuing professional education (CPE) in the area of individual tax. Respondents failed to properly report the sale of a personal residence on a client's tax return.

Respondent failed to report DWI convictions to the Board. Respondent was convicted of felony DWI 3rd in 2022.

Respondent shall complete eight hours of CPE in the area of real estate tax, eight hours of CPE in the area of IRS representation and four hours of CPE in ethics.

The IRS determined entries on tax returns prepared by Respondent, while he held a majority share of the stock of the client, were not supportable and this failure contributed to additional taxes, penalties, and interest being assessed against the client.

A hearing under Board *Rule 519.24(f)* was held before the executive director of the Board on March 29, 2024.

The Board approved Staff's recommendation and ordered that the certificate of Respondent be revoked, and that the Respondent be assessed an administrative penalty of \$10,000 and administrative costs of \$663.11.

Respondent failed to respond to an offer of an ACO by Board staff revoking the certificate of Respondent in lieu of further disciplinary action. Respondent was convicted of wire fraud for misappropriating at least \$1,480,000 by inflating her salary from her employer. A hearing under Board *Rule 519.24(f)* was held before the executive director of the Board on March 29, 2024.

The Board approved Staff's recommendation and ordered that the certificate of Respondent be revoked, and that the Respondent be assessed an administrative penalty of \$10,000 and administrative costs of \$506.70.

Respondent entered into an agreed consent order (ACO) with the Board whereby Respondent was reprimanded, assessed an administrative penalty of \$5,000 and administrative costs of \$705.64 to be paid within 30 days of the date of the Board Order, and placed on limited scope requiring pre-issuance reviews of any audits, compilations, and reviews prior to being issued through a licensed firm enrolled in a peer review program. In addition, Respondent is required to notify her clients that any attest work done through the unlicensed entity is not valid and the clients should be given the option of requesting a refund of the fees paid to Respondent or have the attest work reissued through a licensed firm enrolled in a peer review program as long as that attest work was subject to pre-issuance review.

Respondent issued audited financial statements for two employee benefit plans through an unlicensed entity and which failed to meet professional standards.

The Board approved Staff's recommendation that the certificate and license of Respondent be revoked, and that the Respondent be assessed an administrative penalty of \$10,000 and administrative costs of \$2,813.46.

regarding status of work to be done, failed to return client records, failed to complete an engagement in a timely manner, and failed to respond to Board communications. A hearing under Board Rule 519.24(f) was held before the executive director of the Board on June 20, 2024.

The Board approved staff's recommendation that the certificate and licenses of Respondents be revoked, and that the Respondents be assessed an administrative penalty of \$10,000 and administrative costs of \$2,496,51.

Continuing Professional Education Actions

Additionally, a \$100 penalty was imposed for each year the respondent continues to be in non-compliance with the Board's CPE requirements. The respondents were found to be in violation of Board *Rules 523.111* (*Required CPE Reporting*) and *501.94* (*Mandatory Continuing Professional Education*), as well as *Section 901.411* (CPE) of the *Act*.
